## Board of Directors Nominees

Nominations by petition require 500 signatures and should be accompanied by biographical data and a signed "Notice of Willingness to Serve". Blank petitions and "Willingness to Serve" notices may be obtained from Carole Whitman-Smith at the OE Federal Credit Union Headquarters. No nominees will be accepted from the floor at the Annual Meeting if there is at least one nominee for each position to be filled. In the event that no nomination petitions are filed by the general membership, nominees submitted by the Nominating Committee are elected by acclamation. The results of the 2023 elections will be announced at the Annual Meeting to be held on Saturday, November 18, 2023 beginning at 8:00 a.m. at the Doubletree Hotel located at 7050 Johnson Dr. in Pleasanton, CA.
